<u>MEMORANDUM</u>

Subject: Promotion through Limited Departmental Examination from the post of PRT to TGT for the year 2014-15 to 2018-19 from Main Pancl.

In continuation to this office memorandum dated 08.03.2019, the following PRTs who had been promoted to the post of TGT in their respective subject with year of eligibility as mentioned against their name in column 9. On examination of their particulars it has been found that they are actually eligible for the year as mentioned in column 10 in place of year already shown in the offer of promotion dated 08.03.2019.

Now, therefore they are directed to join at the place of posting as given in the offer of appointment dated 08.03.2019, up to 22.08.2020, failing which the offer of appointment will automatically be treated as withdrawn.

Those who have already joined and there is no point of clash of eligibility in their cases may be treated as disposed of. However in case of the candidates mentioned below who were not allowed to join on the point of eligibility may be permitted to join.

The Principal, KV concerned where the teacher is working is directed to relieve the said teachers well in time (i not relieved already) and he must tie-up with the Principal where the said teacher has been promoted whethe vacancy is available or not. If no vacancy exists at present the promoted teachers must not be relieved. Succases must be forwarded to KVS (Hq) through the Dy. Commissioner, concerned with the proposal of vacancy position in the region for further necessary action. Those teachers who have already relieved and joined their respective place on promoted post as per memorandum dated 08.03.2019 his/her eligibility year may be read a mentioned in column no 10 instead of column no 09 and necessary entries be made in their service book.

3. The Dy. Commissioner, KVS, Regional Office concerned to ensure the implementation of time schedule and relieving of the willing employees. The date of relieving/joining of the teacher may also be intimated by 25.08.2020 to KVS (HQ). In case no vacancy is available, such cases must be forwarded to KVS(Hq) without
