## **NOTICE FOR B.ED QUALIFIED CANDIDATES**

As per NCTE guidelines dated 23<sup>rd</sup> August, 2010, the candidates with professional qualification of B.Ed were eligible for appointment for the post of Primary Teacher **upto 1**<sup>st</sup> **January, 2012**.

In "Clarification Menu" of the PORTAL hoisted by KVS for filling in the information for online submission of applications for the post of Primary teacher, it was mentioned as under:

"In accordance with the Guidelines framed by the NCTE any of the following is essential

- 4-Year Bachelor of Elementary Education (B.El.Ed.)
- 2-Year Diploma in Elementary Education

Candidates pass in CTET but without any one of the above mentioned qualification will not be eligible for Primary Teacher (Post Code-51).

The same were also indicated in the **DROP DOWN** of Online application below the column of Professional Qualification as under:

## **B.El.Ed/Diploma in Elementary Education.**

However, during the conduct of interview for the post of Primary Teacher, it was observed that many candidates with professional qualification of B.Ed also filled in the online applications by giving wrong information about the name of the qualification in **qualification details column**. As such, the candidates having the professional qualification of B.ED were **NOT** allowed to appear for interview for the post of Primary Teacher, being **INELIGIBLE**.

Accordingly, a Notice dated 29.04.2014 was also uploaded in the website of KVS in this regard for information of candidates.

Due to representations from some candidates at the venue of the interview, the competent authority of KVS has re-examined the matter and permitted the candidates having professional qualification of B.Ed, who have qualified the CTET (Paper-I) in June, 2011, to appear for interview as per schedule mentioned in their interview letter for the post of Primary Teacher for the years 2012-13 and 2013-14 **PROVISIONALLY** subject to clarification from National Council for Teacher Education (NCTE) on this matter.

The candidates having professional qualification of B.Ed and having passed CTET (Paper-I), who were called for interview between 21<sup>st</sup> April to 05<sup>th</sup> May, 2014 but could not attend/could not be allowed to appear for interview, will be called for interview separately by providing advance information through SMSes/emails and KVS website etc. All other candidates who have been called for interview from 09.05.2014 to 24.05.2014 are required to attend interview as per the schedule indicated in their call letters for interview.

This notice is issued in supersession of earlier notice dated 29.04.2014.
