The terms and condition for participating in the auction are as follows:-

2. The cost of tender form be obtained by remitting Rs.100/- by means of crossed DD favoring KVS(HQ) New Delhi.
3. Tender form without the D.D for Rs.100/- will be summarily rejected.
4. The last date of submission of tender form is 26th Oct.2009 by 5.30 P.M.
5. Alongwith the tender and 100/- D.D the participant has to enclose a D.D. for the rate quoted by him. The two cars will be auctioned "as is where is" condition in the premises of KVS(HQ) New Delhi.
6. The interested Party can visit the KVS(HQ) New Delhi for inspection of the said vehicle on working days from 09.00 AM to 5.30 PM.
7. In case the tender is accepted for the highest value, in r/o each car the tenderer has to lift the vehicle immediately at his own cost, failure to lift the vehicle by the tenderer immediately, KVS will levy the demurrage charges of Rs.500/- per day for 10 days as demurrage charge and thereafter, the Vehicle will be forfeited.
8. The tenderer has to submit a separate D.D. towards the amount quoted for each car, in case, he/she is willing to participate in auction for both cars.
9. The KVS is having full right to decide to accept or reject the quotation without assigning any reason and no communication will be entertained in this regard.
10. The sealed tender will be opened in the Chamber of the undersigned at 11.00 AM on 27.10.09.
11. D.D. submitted by unsuccessful tenders will be returned within 10 days.
12. The R.C. books and other concerned document of the car will be handed over to successful bidder by following the procedure.
13. The tenderer will immediately get the Vehicle transferred in his/her name at his own cost.
14. The KVS will not be responsible for any sort of damage/loss to the vehicle once it is auctioned & accepted by the highest bidder.
